The Eswatini Communications Commission is a regulatory body established in terms of the Eswatini Communications Commission (ESCCOM) Act, 2013 to regulate and supervise the electronic communications sector including electronic communications networks and services.

As part of the Commission's mandate to protect the integrity of networks, protect consumers, avoid harmful interference and in accordance with section 5(1) of the Electronic Communications (Importation, Type Approval and Distribution of Communications Equipment) Regulation, 2016, the Commission is obligated to ensure that all electronic communications equipment is type approved and accepted by the Commission prior to its use in the country. Type approval is a regulatory process administered by the Commission to ensure that all electronic communications equipment intended for use within the Kingdom of Eswatini complies with established technical standards and regulatory requirements before it is imported, marketed, or deployed. This process involves the assessment and certification of equipment to confirm that it operates efficiently within designated frequency bands, does not cause harmful interference to existing networks, and meets safety, quality, and interoperability standards.

Following previous stakeholder submissions and in accordance with section 18 (3) of the **Electronic Communications (Importation, Type Approval and Distribution of Communications Equipment) Regulation, 2016** the Commission has reviewed the Type Approval fee structure. The draft proposed fee schedule is now available on the ESCCOM website, www.esccom.org.sz for stakeholder review and comments.

As part of the public consultation process envisaged under Section 32 of the ESCCOM Act, the Commission hereby invites stakeholders and interested persons to submit written comments via email to info@esccom.org.sz on or before **27 July 2026**.
